### Fall 2020 Scenarios

#### Two or three-year programs

I started a <u>two-year or three-year program</u> in September 2020. If my classes were delivered virtually due to COVID-19, what do I need to know?

If you intend to apply for the Post-Graduation Work Permit (PGWP) after you complete your program, you need to have either applied for a study permit, a <u>letter of introduction (study permit approval)</u>, valid study permit, or <u>a study permit approval-in-principle</u> starting your program.

As

an NBCC obligation, you need to be present in Canada to meet your program requirements.

You will be able to continue your program of study in a blended format from inside Canada and <u>maintain</u> <u>eligibility</u> for the post-graduation work permit (as long as you meet all other PGWP criteria), until further notice from Immigration, Refugees, and Citizenship Canada (IRCC).

If you chose to start studying online from outside Canada

there are associated risks

(mainly, a potential study permit refusal) which would make your studies no longer eligible for the PGWP. Please review <u>this information</u> if you have started your studies without a final study permit approval.

#### 1.5 year programs

If you intend to apply for the Post-Graduation Work Permit (PGWP) after you complete your program, you need to have either applied for a study permit, a <u>letter of introduction (study permit approval)</u>, valid study permit, or <u>a study permit approval-in-principle</u> starting your program.
